Summary of Changes to Assessment Materials for 2025–2026

Handbooks:

- The template content (e.g., Context for Learning, commentary prompts) has been removed from the handbooks, so the templates are the single source for this information starting this year.
- Embedded video links to candidate support webinars have been added.
- Overview content and task instructions have been streamlined.

Templates:

- New version number and copyright date to correspond to the updated handbook.
- Templates are the single source for prompts starting this year.
- The Task 2: Instruction Commentary template for most assessments has had an additional positive learning environment prompt added.

Candidate Support Resources:

- There are no longer separate URLP documents and Academic Language Handouts starting this year since this content has been incorporated into the handbooks.
- The Making Good Choices documents (general, Special Education, and Special Education for California versions) have been updated for this year with a new version number and copyright date.
